RESOLUTION OF THE GOVERNING BODY OF THE TE-MOAK TRIBE OF WESTERN SHOSHONE INDIANS OF NEVADA

RESOLUTION NO. 12-TM-36

**BE IT RESOLVED BY THE TRIBAL COUNCIL OF THE TE-MOAK TRIBE OF THE
WESTERN SHOSHONE INDIANS OF NEVADA, THAT**

- WHEREAS,** this Organization is a recognized Indian Organization as defined under the Indian Reorganization Act of June 18, 1934, as amended to exercise rights of home rule and to be responsible for the promotion of economic and social welfare of its tribal members; and
- WHEREAS,** the present Te-Moak Tribe's Judicial system is governed by the Court of Indian Offenses (CFR) with Federal Magistrates; and
- WHEREAS,** these Magistrates serves as a tribal judge and not having an Appeals Officer, therefore, causing a void in the appellant system, and
- WHEREAS,** there is a need for providing an adequate Court of Appeals for the Te-Moak Tribe of Western Shoshone Indians of Nevada; and
- WHEREAS,** the Appellant Court Program provides a service of proper due process and hears appeals made from the lower Tribal or CFR Court, and
- WHEREAS,** the Inter-Tribal Court of Appeals of Nevada is a Court of competent jurisdiction to hear appeals.
- NOW, THEREFORE BE IT RESOLVED,** that the Te-Moak Tribal council hereby rescinds Resolution #07-TM-05 in its entirety and **authorizes** the Inter-Tribal Courts of Appeals of Nevada to hear any and all appeals arising from the decisions of the Te-Moak CFR Court of Indians offense.
